General Fund Budget Fiscal Year 2018 & 2019

#### Revenues:

#### **Developer Contributions**

The Developer provides funding to the District to pay for operating expenditures incurred during the Fiscal Year.

#### General & Administrative:

#### Supervisor Fees

Chapter 190, Florida Statutes, allows for each Board member to receive \$200 per meeting, not to exceed \$4,800 per year paid to each Supervisor for the time devoted to District business and meetings.

#### **Public Official Insurance**

The District will incur costs for Public Official insurance coverage.

#### **District Management**

The District will incur costs to provide management services. These services include, but are not limited to, advertising, recording and transcribing of Board meetings, administrative services, budget preparation, financial reporting, and assisting with annual audits.

#### **Engineering**

The District's Engineer will be providing general engineering services to the District, e.g., attendance and preparation for the monthly Board meetings, review of invoices and requisitions, preparation and review of contract specifications and bid documents, and various projects assigned as directed by the Board of Supervisors and the District Manager.

#### **District Counsel**

The District's Legal Counsel will be providing general legal services to the District. Among these services are attendance at and preparation for monthly Board meetings, review of operating and maintenance contracts, review of agreements and resolutions, and other research assigned as directed by the Board of Supervisors.

#### **Audit Fees**

The District is required by Florida Statutes to have an independent certified public accounting firm to conduct an annual audit of its financial records.

#### Travel & Per Diem

Represents the travel expenses incurred related to District staff.

#### Telephone

Represents expense for telephone and conference calls that are reimbursable by the district.

#### Postage

Represents the expense of mailing of correspondence, payables, and overnight deliveries, that are considered reimbursable by the district.

#### <u>Copies</u>

Represents the expense of printing of agenda packages and copying correspondence, that are considered reimbursable by the district.

#### Legal Advertising

The District will incur expenditures related to legal advertising. The items for which the District will advertise include, but are not limited to meeting schedules, special meeting notices, and public hearings, bidding etc. for the District based on statutory guidelines.

#### Miscellaneous

Represents expense for unbudgeted administrative items that do not fit into any other expense

Website Fees
The District incurs costs related to the District's accounting and information systems, District's website creation and maintenance, electronic compliance with Florida Statutes and other electronic data requirements.

#### Dues, Licenses & Subscriptions

The District is required to pay an annual fee to the Department of Economic Opportunity for \$175. This is the only anticipated expense in this category.
